

LLANTRISANT TOWN TRUST

BYE-LAWS & REGULATIONS

For the Management of Commons and the exercise of pasture rights on Common Lands - Cymdda and Graig – made by the Trustees of Llantrisant Town Trust, under the authority of the Scheme, dated 17th December, 1889, as amended.

All previous bye-laws and regulations are rescinded and replaced.

1. No person unless authorised by Trustees shall affix or post any bill, placard, or notice to or upon any wall, or fence, or upon any tree, railing, or seat on any of the said Lands.
2. No person or persons shall hold or take part in any meeting for the purpose of any political, religious demonstration or of any religious service, or any organised social event, on the said Lands, without the permission of the Trustees.
3. No person shall cut any tree, sapling, shrub, under-wood, or plant, or damage or deface, or in any other way damage or remove any soil, turf, gates, notice boards, or other properties on the said Lands, save that those entitled to the grazing rights on the said Lands may cut any Fern or Gorse thereon, and persons so entitled shall cut only reasonable quantities for their own use, and not for sale, nor for the use of any other persons.
4. No person shall deposit any soil, refuse, or any substance whatsoever on any part of the said Lands, without the consent, and by the directions of the Trustees.
5. No person shall roll or throw stones on the said Lands, nor shall any person do any acts thereon which may be dangerous to persons or animals.
6. No person shall burn Fern and Gorse on the said Lands, without the consent, and by the directions of the Trustees.
7. All motorised vehicles are excluded from the said Lands, except with the consent, and by the directions of the Trustees.
8. No tent or any other temporary structure or caravan shall be placed on the said Lands, without the consent, and by the directions of the Trustees.
9. No entire horses or bulls over six months old shall be allowed on the said Lands.
10. No person shall turn any animal suffering from any disease on the said Lands.
11. No person shall turn any cattle on the said Lands without providing to the overseer their identification numbers. No cattle shall be allowed on the said Lands without prior notification of the overseer. Within seven days of the cattle being placed on the said Lands, the overseer shall be provided with the cattle identification numbers and appropriate payment in full.

12. No person shall turn any horse or pony on the said Lands without it being micro-chipped. No horse or pony shall be allowed on the said Lands without prior notification of the overseer seven days in advance. The horse or pony shall be presented to the overseer by the grazier for the purpose of confirming identification, prior to placing the animal on the said Lands.
13. No person shall have any foal born on the said Lands without it being micro-chipped and being presented to the overseer by the grazier for the purposes of confirming identification, within twelve months of birth.
14. The welfare of any animal on the said Lands shall be the sole responsibility of the grazier at all times.
15. No sound animal shall be removed from the said Lands without prior notification of the overseer.
16. Any and all animals on the said Lands may be gathered at any time, without notice to graziers, for the purpose of ensuring compliance with the bye-laws and regulations.
17. The overseers or some other authorised persons are empowered to remove or impound any animals not in accordance with these regulations, or any animal not being the property of persons entitled to the grazing rights on the said Lands, or any animal found not to be in sound condition through neglect or illness.
18. The Trustees reserve the power to regulate the number of Stock grazing on the said Lands and to regulate the positions and portions of ground for grazing.
19. No species of animal, other than those provided for in these bye-laws and regulations, shall be permitted on the said Lands, except dogs under effective control.
20. No person shall be allowed on the said Lands in search of Game, Hares, or Rabbits, without the consent of the Trustees, except those entitled to the grazing rights.

Every person who shall offend against any of the foregoing Bye-Laws will be proceeded against as the Law directs or according to the disciplinary procedures established by the Trust.
