## **THE DAUGHTER OF A FREEMAN**

### **ESSENTIAL DOCUMENTS TO BE SUBMITTED SUPPORTING THE APPLICATION FOR THE FREEMEN'S ROLL**

In order to qualify for admission to the Freeman's Roll, the following documents should be submitted to Llantrisant Town Trust, together with the Form of Claim no later than the **31st March** of the year in which the annual Court Leet is held.

- a. Applicant's Birth certificate [or photocopy] **showing the names of the parents**. No other form of certificate is acceptable. Copies are available from your Registry Office if required.
- b. Enrolment fee of £100.00 to be sent as a cheque (made payable to Llantrisant Town Trust.) to the Clerk's address below Alternatively this can be made as a Bank Transfer to Llantrisant Town Trust. Sort Code: 30-91-18; Account:02562968
- c. **A photograph of each applicant** for the Freeman's Roll is required. This can be submitted with this application or via email to the Trust.

**Please Note: We require all of these documents before accepting any enrolment application. Failure to submit them will cause the application to become invalid.**

## **ATTENDANCE AT THE COURT LEET**

All applicants are expected to attend in person at the Court Leet, and to be accompanied by a relative or sponsor, so that she may be formally presented and her identity confirmed. Valid reasons for failure to attend the Court Leet shall be given in advance and applicants may be enrolled in absentia. Trustees may, at their discretion, require the attendance of all applicants at the Court Leet.
